## Community Criteria for RNIP Program

**Step 3:** Once you've been deemed eligible based on <u>steps 1 and 2</u>, the TEDC will prioritize applicants who are most likely to settle and reside in the Timmins region for the long-term and contribute to the local economy according to the Community Criteria. Applicants receive a score using the points-based system below. [**As of September 23, 2022**]

At the moment, **applicants need to achieve a total score of 60 or above** to be considered for recommendation. Note: As they are not considered priority occupations, applicants with a job offer in NOC 62010 and NOC 62020 need to achieve a total score of 70 or above to be considered for recommendation.
